1	I/We understand that the Chromebook and its accessory equipment are the property of the Midland Park School District.
2	I/We understand that the student, with the support of the parent, is responsible for the daily care and maintenance of the Chromebook.
3	I/We understand and agree to abide by the rules and regulation of Board Policy 2361 , Technology Acceptable Use. Failure to abide by this policy will result in disciplinary action.
4	I/We understand that I/we must report all Chromebook damages, or the theft/loss of the Chromebook to the technology department at your school.
